THREE YEAR LIMITED WARRANTY

What is covered under the warranty?

Reading warrants each Steel Service Platform, Landscape, Stake Rack, Dump Bodies, Redi-Dek, REV-PAC, RTB-813 Hoist and Pickup Tool Boxes to be free from defects in material, workmanship and rust-through or corrosion from date of purchase. Reading warrants its factory-applied topcoat against material defects for a three (3) year or 36,000 mile period, whichever occurs first from date of purchase. This Warranty applies only when the Product is properly installed by an authorized Reading installer, properly maintained and used for the purpose for which it was designed.

Who benefits from this warranty?

Reading's obligation under this Warranty automatically applies to the first purchaser of the Product. Subsequent owners must register the product with Reading to reinstate the remaining warranty coverage period at no charge.

How is a warranty claim handled?

The purchaser shall immediately notify the local Reading distributor or Reading Truck Body, LLC (in writing) of any claim under this Warranty, setting forth the date of purchase of the Product, model and serial numbers, and giving a detailed description of the alleged defect including photographs of the specific defect and the complete unit. All repairs must be authorized by Reading prior to any work being performed.

If after inspection Reading determines the Product is defective in material or workmanship as claimed, Reading shall have the option to repair the defect or replace the Product or any part, Labor required to repair defective material or workmanship will be covered for a period of (3) years or 36,000 miles, whichever occurs first, from date of purchase. Reading shall not be liable for any labor costs for installation, removal or reinstallation of any defective Product to or from the vehicle, any transportation costs, any rental reimbursement, loss of vehicle use, inconvenience, storage, lost time/pay, etc.

Purchaser shall prepay all freight charges for returning the Product to Reading, or any other location designated by Reading, and for receiving any replacement. Any replacement shall be F.O.B. Reading's plant.

What are the exclusions to the warranty?

This warranty shall not apply to:

1. Accessories or services not furnished by Reading or damage/corrosion caused by these accessories or services, such as optional parts, aftermarket products, components, installation, finish painting, lettering, wiring or modifications.
2. Damage caused by carrying corrosive materials.
3. Damage or corrosion, including surface rust, due to normal wear and tear such as stone chips, chemical treatments and exposure due to airborne contaminants/pollutants.
4. Damage due to accident, misuse, abuse or alteration.
5. Product(s) purchased in prime paint and installed by original owner.
6. Product(s) purchased and used outside the USA and Canada.
7. Product(s) not properly maintained per maintenance instructions.
8. Platforms only – Wood floors that are found defective, in which case the repair or replacement cost to Reading shall be limited to the following percentages: First year – 100%, Second year – 50%, Third year – 25%.

DISCLAIMERS

Reading warrants its Products only as stated in this Warranty. Reading makes no other warranties, express or implied, and disclaims all other warranties, including any implied warranty of merchantability or fitness for any particular purpose.

Reading's obligations are limited to those expressed in this Warranty, and Reading shall not be liable to the purchase or any third party for any direct or indirect, incidental or consequential damage or loss.

Some states do not allow limitations on how long an implied warranty lasts or exclusions or limitations of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

If any Product is improperly installed, altered, misused, damaged or otherwise tampered with, the foregoing Warranty shall lapse and become null and void.

This Warranty shall be enforced and construed in accordance with the laws of Pennsylvania.

No person is authorized to modify or add to the foregoing Warranty.
